Announcements

SPP is now on Twitter! Twitter hosts a vibrant academic community, where users share ongoing research, pose questions to substantive experts, advertise professional opportunities, and develop professional connections. Many university departments--at OSU and elsewhere--maintain active Twitter accounts, from which they broadcast faculty and student accomplishments, recent or ongoing research activity, and professional opportunities. With the approval of the SPP Executive Council, we plan to do the same.

Throughout the year, we will post content approximately once per week. It will focus on research and news from SPP. The content will be "positive" and will avoid partisan activity. You can see some of the early activity by going to https://twitter.com/OSU_SPP.

Questions? We have some answers below.

- **What is the SPP account name (or handle)?** @OSU_SPP. If you do not use Twitter, you can still read the posts at: https://twitter.com/OSU_SPP.
- **Who manages the account?** The team of administrators includes one faculty member and at least one graduate student. This year, those people are Brett Burkhardt and Gautam Anand. These people volunteer for the position.
- **How do I start using Twitter?** Check out Twitter's "Getting Started" guide at <https://help.twitter.com/en/twitter-guide>.
- **I have news! How can I use the SPP account to share it?** If you are not on Twitter, simply send an email (and a link if available) to an account administrator, who will share a post on Twitter. If you are on Twitter, you can tag @OSU_SPP in your own post, and we will retweet it.
- **How can I help spread the word about @OSU_SPP?** If you are on Twitter, make sure to follow the account, and share some of our posts with your followers. If you are not (yet) on Twitter, sign up and follow the account.
- **I am not on Twitter. Will the SPP account write about me?** Short answer: Yes, unless you opt-out. Longer answer: It is likely that the administrators will want to share positive news about someone not on Twitter (e.g., a recent publication or an award). Lacking a Twitter account, this person would not be "tagged" in Twitter and therefore would not receive any direct feedback via Twitter. If you would like to opt-out of any references in the SPP Twitter account, you may notify the administrators, who will not Tweet about your impressive accomplishments.

Assistant Professor in Environmental Sociology Department of Sociology University of Kentucky

The Department of Sociology at the University of Kentucky in Lexington, Kentucky invites applications for a tenure-track, assistant professor faculty position to begin August 1, 2020. The department is seeking a scholar with expertise in environmental sociology. We encourage candidates whose research and teaching add to existing departmental strengths and needs (see www.as.uky.edu/Sociology), including our longstanding commitment to research on environmental sociology and rural sociology with particular emphasis on environmental justice in natural resource-dependent communities. This individual will teach 2/2 at the graduate and undergraduate levels. The successful candidate will have the opportunity to be a faculty affiliate in relevant interdisciplinary research and service centers at the University of Kentucky, such as the Tracy Farmer Institute for Sustainability and the Environment (<https://www.research.uky.edu/tracy-farmer-institute-sustainability-and-environment>), the Center for Health Equity Transformation (<https://chet.med.uky.edu/>), the Center for Equality and Social Justice (<https://www.cesj.as.uky.edu/>), and the Appalachian Center (<https://appalachiancenter.as.uky.edu/>).

Candidates should have a Ph.D. in Sociology or related field in hand at the time of the appointment.

Applicants should submit the following: 1) a cover letter, 2) a curriculum vita, 3) a research statement (upload as Writing Sample), 4) a teaching statement upload as Specific Request 1), 5) samples of research (upload as Specific Request 2), and 6) a diversity statement (upload as Specific Request 3). The statement of research interests should identify the emphases of the applicant's research program and specific research plans and goals. The teaching statement should describe the applicant's teaching philosophy and pedagogical approaches, as well as specific courses that the applicant has taught or is prepared to teach. In 1-2 pages, the diversity statement should reflect the applicant's commitment, approaches, and insights related to inclusion, diversity, and equity. Also provide the names and contact information for three references

when prompted in the academic profile. This information may be utilized to solicit recommendation letters from your references within the employment system.

Review of applications will begin on October 31, 2019 and will continue until the position is filled.

2020 Theme Statement

The theme for the 2020 annual meeting is "[Democracy, Difference, and Destabilization](#)." Annual meeting program chairs, Efrén Pérez, University of California, Los Angeles, and Andra Gillespie, Emory University, invite you to submit a proposal for the annual meeting!

In the United States, democratic institutions are generally thought of as bulwarks against manifold threats, both inside and outside of the American polity. Indeed, the assumption has been that our nation's constitution is solid and prescient enough to thwart—or at the least contain—the more authoritarian impulses of citizens and elected officials alike. Donald J. Trump's election to the presidency of the United States in 2016 has dramatically called into question this working assumption. Yet President Trump's ascendance to executive power is more epilogue than prologue to the inclusivity of American democracy.
